Finally, we received the good news that Jorge's citizenship case has been re-opened. So, they are giving him a redo of his interview!!! Praise the Lord!!! We are so thankful for this and know that God is in control of the times even when we don't understand all of the ups and downs.

That means for our family the following:

1. Preparing our family for another move (Emotionally and Spiritually)
2. Visiting as many supporters/churches as possible before we leave to communication the needs.
3. Making all of the necessary preparations for travel. (Tickets, travel documentation, storing/liquidating our personal assets here in the U.S.)

Our plan is to make one final effort to see if Sara can travel to Venezuela on her current visa, and if that is denied, we plan to join the Team Expansion workers in El Salvador. It has been especially stressful knowing what the brethren are going through in Venezuela, being unable to travel and not knowing exactly where we will end up. So, please pray for our well-being through it all.

Other good news from this month is that 2 teenage girls attending one of the cell groups gave their lives to the Lord after hearing the testimony of another Christian. They identified with his struggles and his need to finally accept Jesus as Lord! And, a new family is being mentored in the Word as a result of the soccer ministry.
